



Guaranteed Admissions Agreement Immaculata University and York Catholic High School

Purpose

Immaculata University is committed to providing quality education to York Catholic High School students by providing access to and opportunity for post-secondary education.

Guaranteed Admissions Program

Under this agreement, York Catholic High School students will be guaranteed admission into Immaculata University as a full-time, first time matriculated college student on the basis they:

- complete York Catholic High School with an earned high school diploma;
- earn a minimum GPA of 2.5 or better on a 4.0 scale
- combined SAT score of 990 (critical reading and math); and
- satisfy all other application requirements.*

*The guaranteed admission applies to most majors at Immaculata University. Some majors are excluded: e.g. Nursing, Allied Health, partnerships with third-party agreements, and others.

In accordance with the terms and conditions of this guaranteed admissions agreement, Immaculata University will:

- waive the undergraduate admissions application fee;
- provide on-site personal admissions advisement by appointment for prospective students and parents at York Catholic High School; and
- provide one on-site general college search and financial aid workshops and presentations at York Catholic High School per year.

York Catholic High School will:

- promote the Guaranteed Admissions Program to juniors and seniors; and
- provide one opportunity in the fall of both the 2019-2020 and 2020-2021 academic years for instant decision day at York Catholic High School

York Catholic High School/Immaculata University Merit Scholarship

In recognition of the academic accomplishments of York Catholic High School students considering Immaculata University, Immaculata University agrees to provide a minimum of \$9,000 academic merit scholarship to qualifying students. The merit-based scholarship will be awarded to York Catholic High School students who meet the academic requirements and who will begin attending Immaculata University in Fall 2019 or Fall 2020. This academic merit scholarship is renewable for three additional consecutive years of full time undergraduate enrollment at Immaculata, provided the student maintains consecutive full time status at Immaculata and the GPA as outlined in their scholarship letter. The scholarship will be subject to any remaining terms and conditions imposed by Immaculata University and will be further outlined at the time of acceptance.

Students with a higher GPA may qualify for additional merit-based aid. In addition to the academic merit scholarship, York Catholic High School students will also qualify for the Immaculata University's Catholic School Grant in the annual amount of \$2,000. This grant is renewable for three consecutive years, provided that the student maintains full time status.

When the York Catholic High School student accepts the Immaculata University merit scholarship and Catholic School Grant and matriculates at Immaculata as a full time student, the existence, or lack thereof, of an ongoing Guaranteed Admissions Agreement between Immaculata and York Catholic High School will have no negative bearing on the student's continued qualification for any merit academic scholarship or grant provided by Immaculata to the student at the time of their enrollment as a first time, full time freshman in the Fall of 2019 or the Fall of 2020.

Mutual Terms and Conditions

Term of Agreement. This Agreement is effective for the Fall 2019 full time admission to Immaculata University. Unless cancelled as provided for in this Agreement, this Agreement will also be effective for the Fall 2020 admission to Immaculata.

Terms of Agreement. Immaculata University or York Catholic High School may terminate this Agreement for any or no reason within ninety (90) days advanced written notice. Either party may terminate this contract in writing in the event of a substantial breach which remains uncured following thirty (30) days prior written notice of breach.

Modification of Agreement. This Agreement shall only be modified in writing with the same formality as the original Agreement.

Entire Agreement. This Agreement represents the entire understanding between the parties. This Agreement supersedes any prior agreement between the parties with respect to the subject matter hereof. No other prior or contemporaneous oral or written agreements or promises exist in regards to this relationship. The paragraph headings are for convenience only and for no part hereof.
