



## WAYS TO GIVE

### ONLINE GIVING

Click on the Give button at the top of our website to make a secure online gift. Credit cards gifts (MasterCard, Visa, and Discover) are all gratefully accepted for one time, monthly or quarterly gift transactions. Please know a small transaction fee is required for credit card gifts.

### CHECKS

Checks should be made payable to York Catholic and sent in a YC gift envelope (in each issue of *Greensleeves*) or mailed to: YC Advancement Office, 601 E. Springettsbury Avenue, York, PA 17403.

### STOCK & SECURITIES

### EITC & OSTC

Corporate donors can earn up to 90% in tax credits when participating in the OSTC (Opportunity Scholarship Tax Credit) or EITC (Educational Incentive Tax Credit) programs. These vital programs provide needed tuition assistance money for our talented students. Corporate donors must indicate Neumann Educational Foundation/York Catholic on the one page application.

### SPE

Special Purpose Entity (SPE) allows Pennsylvania individuals to redirect 90% of their personal state income taxes to York Catholic. SPE is based on tax liability, not income, therefore each taxpayer's situation will differ. Participants must be PA residents where at least one spouse is employed or has an ownership interest in a PA for-profit business. An individual or couple filing jointly must have a state tax liability of \$3,500 or more to participate. To see if you may qualify, you can find your PA tax liability on Form PA-40 Line 12 of your most recent tax return. 100% of participant contributions are distributed to the school. The money you redirect to York Catholic is for educational purposes, specifically tuition assistance.

If you would like to take advantage of this opportunity, please follow these steps:

The completed matching gift form must be returned to York Catholic for proper gift credit and acknowledgement.
